Matters arising from the previous minutes:

Letter to the State Minister, reiterating KCCC stance on the roundabout proposed for the bottom of Katoomba & Waratah Streets, in progress. The project needs to be reviewed in view of new building developments in the immediate area contributing to heavier traffic demand in the future.

Noted, that the roundabout idea had been trialled before, and abandoned back in late 80s early 90s.

### **Streetscape Issues**

At the Executive meeting with the General Manager BMCC, Dave Allen raised the cleanliness issue in the CBD. BMCC have tried, but they're slipping and we need to keep the issue alive.

Motion from RS:

*KCCC raise the fact there is a lot of concern that BMCC haven't been able to address their own maintenance schedule, in a timely manner, for Katoomba CBD.*

Seconded MJ / CK  
Unanimous.

### **Street Art**

Manager of Mountain Youth Services Team (MYST) Damian Cooper and Jarrod addressed the meeting as part of an effort to seek consensus with the community. MYST is a non profit

community youth service, which has received Community Cultural Partnerships Program funding for street art projects in or around Katoomba. They have met with our KCCC graffiti cleaning team to discuss spots that might benefit by street art murals as studies have shown it helps to ward off re-occurring graffiti. Jarrod explained that over 2 years, 30 works have been completed around the Mountains, with 3 goals achieved: murals beautifying certain areas, a creative outlet for young people, and a breaking down of barriers between young and old.

Discussion ensued. Froma Lane is currently out of bounds as this is being developed as a linkage to the new supermarket/cultural centre, Davis Lane is earmarked for more development on the Butterfly Walk with Katoomba Public School, but Penny Lane may be available. The point was made that we are a tourist town and would like this theme promoted. It is a world heritage area so it would be desirable to develop diversity and not too much of one style of art. Also a theme that would link the wider community, both older and young people, should be encouraged. Cllr Mays suggested the team should seek wider community consultation. The challenge is too many murals – with another 6 sites proposed in addition to the existing pieces. Noted, letters have been received from community members who do not accept the street art pieces that are already here.

Discussion around a theme to the town – ‘art deco’ is a theme much appreciated here. Noted, there is very little graffiti in Katoomba – it is well kept up, so that is not so much a problem.

Working meeting called for January 10<sup>th</sup> 2011- 2 members from KCCC will attend, for further discussions.

### General Business

#### Graffiti

CCTV paid off when it caught on tape, 2 people ‘graffiting’ in the CBD. Some graffiti noted for cleaning in Froma Lane, Davis Lane and Penny Lane.

#### Noise Pollution

It was noted very large trucks are using Katoomba Street CBD, and creating unwelcome noise. Some local buses are also ‘roaring’ up Katoomba Street and making a lot of unpleasant noise.

#### Buses at Echo Point

Foster Road has been turned back to its 3L weight restriction after works were completed at Echo Point. But some buses are still using it despite the restriction. MJ will call Fantastic Aussie Tours to alert them to the problem.

#### Echo Point

Noted there used to be 8 trees at Echo Point as part of the redevelopment there. Now there are none. Apparently they were vandalised and had to be removed. Question is: are they going to be replaced? Cllr Mays undertook to raise this.

#### RSL Carpark

Mw has written to the RSL management on behalf of KCCC regarding replanting of the trees along the carpark boundary on Lurline Street. After approaching both for discussion, it was revealed both BMCC and the RSL were waiting for each other to initiate the process. MW handed, in person, the necessary forms to the RSL to restart the process. It was suggested that possibly the RSL don't really want to it – we need to keep the pressure on them.

#### Pots in Katoomba Street

Vandals have tried to pull 2 bay trees out - 1 bay tree was returned – but caught on CCTV. Disc made available to the police. MJ (The Carrington Hotel) has very generously purchased more bay trees at their own cost. Thank you. The pots will be decorated on Fri 17<sup>th</sup> for the Xmas night shopping event.

MW moved KCCC should fund Christmas decorations to the value of \$100 for the pots.  
Unanimous.

#### Tidy Town Project

Cllr Mays will be putting a motion to Council for the BM to join in again with the Tidy Towns Project.

#### Working Bee to clean up Lurline Street

Yet to be advised- but some enthusiasm for a working gang to get together. Council needs to be alerted to spray afterwards.

#### Tinsel for Christmas

All participating retailers will receive tinsel decorations in recognition of their efforts, donated by the KCCC Christmas Committee.

#### Davies Lane

The historical marks on the brickwork in Davies Lane need public recognition by way of a brass plaque describing its significance. Cllr Mays will put in a request to Council.

#### Pavers in the CBD

Pavers in Katoomba Street need a very strong pressure cleaning as the fungus keeps returning. Fungicide not allowed to be used.

#### Sunflower Project

It was reported a small town in New Zealand runs a project whereby every household is encouraged to join in the community event of growing sunflowers in their front yards – an idea that could be used here as part of Slow Food. This idea was thought to have some merit and so discussion around the idea ensued.

**Burmah Petrol Station on GWH Katoomba**

The Burmah has been sold to Ben Dunn who owns a few outlets around the Mountains. It will remain a BP station but he is keen to put some money in to tidy it up - a good thing given its prominence in the entry to our town. Apparently Woolworths Caltex is going ahead with its development on the corner of Albion St and GWH.
